## **Meeting Minutes**

The WDTSA December meeting was called to order by Chairman Tom Heckert at 6:36 PM.

Engineer's Report: Mr. Satteson presented the WDTSA board with several items. A written report, a proposal with an estimated fee for assistance with the WDTSA Sanitary Sewer Basement Inspection Program, and a draft of the Sanitary Sewer Inspection Letter. Mr. Satteson gave an overview of all presented. The board discussed how to properly enforce the WDTSA Rules and Regulations if illicit stormwater connections are found. Timelines and fines were discussed thoroughly. It was decided to add a provision to Section 1.07. of WDTSA Rules and Regulations and table HRG's proposal and letter for the next meeting.

Operator's Report: Mr. Oberdorf reports that Mr. Rehab quoted a price for lining the 700 feet of sewer line along Fornwalt Lane and will be \$45- \$50 a linear foot and would cost approximately \$35,000.00. They will not be able to start until February and will be televising the line first. Mr. Oberdorf will also get an estimate from Keiser's for cost to dig
